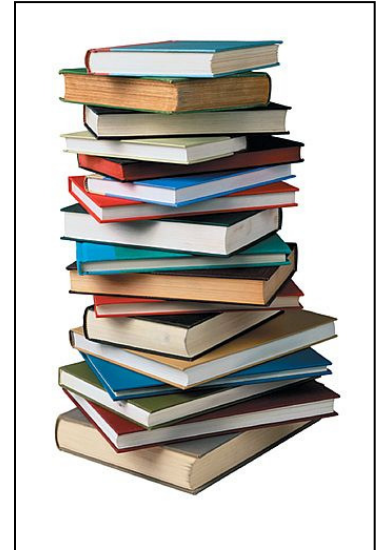




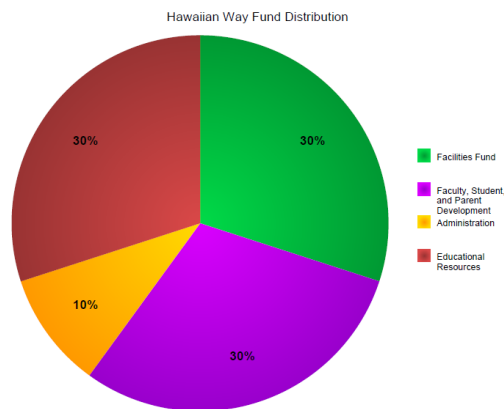
The Hawaiian Way Fund at Kawaikini NCPCS
