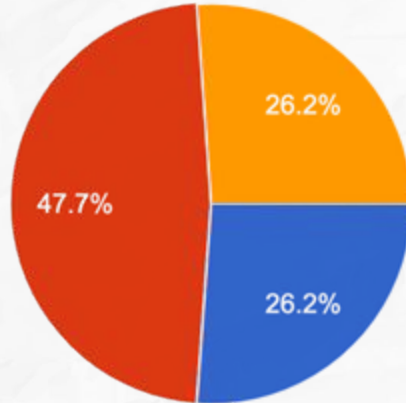

Plan to Return: 'Ohana Survey

If given the options below, which learning model would you prefer for quarter 3?



- A/B Rotation Model (Rotation of face to face all day, 2 x/week and distance learning)
- Face to Face Everyday (Keiki attends school all day everyday-with recommended safety guidelines)
- Complete distance learning (keiki stays home all day to receive instruction)

Plan to Return: Priorities



- 1) Bring all keiki back for in-person instruction (100% or blended models).
- 2) Ensure safety for all students & staff.

Recommended Benchmarks For Reopening

Guidance to Reopen Subcommittee

#1

Kawaikini will implement, and transition between, its learning models guided by available data on **levels of community transmission.**

#2


Kawaikini will implement, and transition between, its learning models in alignment with its capacity to institute and enforce appropriate **mitigation strategies.**

#3

Kawaikini will **compare** reopening plans and experience of **other schools including DOE, Charter, and Private schools** to help inform its decision-making.

Highlights: Mitigation Strategies



- The school adopt a system whereby all faculty and staff accessing the campus are trained on all protocols.
 - The school adopt the Department of Health Suggested Requirements for In-person Learning, Blended Learning, Learning from Home.
 - A handout be created for parents and family of students to help them understand what is expected of them at every stage of the reopening process.
 - A process whereby parents, faculty, staff, and students self-disclose if they or someone in their household has been exposed to COVID-19.
 - A process whereby parents, faculty, staff, and students self-disclose if they or someone they live with have traveled outside of the island of Kauai.
 - A policy stating that casual off-island travel is not recommended. If students/staff/family travel for essential reasons, the traveler and persons in contact with the traveler cannot re-enter the Kawaikini Campus until the traveler receives a negative test result after 72 hours of returning to Kauai.
 - Provide a regular update of covid related information that is pertinent to the school (i.e., post updates on the school website, etc.).

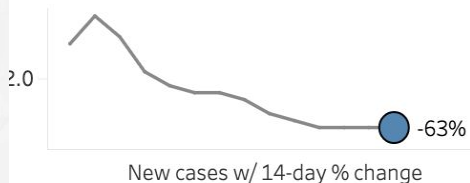

Transition between Models

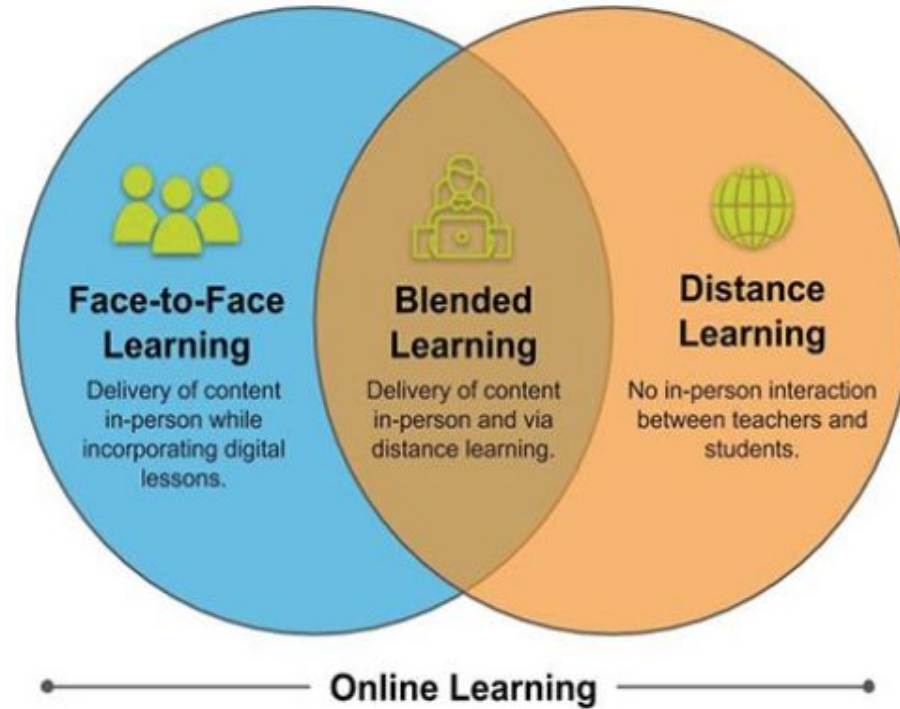
- ❑ Guided by 3 benchmarks for reopening
- ❑ Following the DOH advisement, will remain in each phase for 2 cycles or 2 weeks then revisit and assess for safe movement into another phase
- ❑ Transition from distance learning with increased access to on campus to hybrid model on January 5

QUARTER 3 PLAN

- Decision by school administration and Governing Board to return to school for quarter 3 with a hybrid learning model to include both in person learning on a blended schedule with distance learning options.
- Quarter 3: January 5-March 12
- January 4: Kumu work day (No students)
- Reduces in person capacity to 50-70% students on a given day
- Offers consistency with a distance learning day on Wednesdays in the event full distance learning is necessary

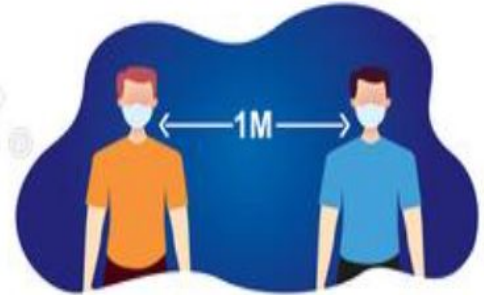

Requirements for In-Person Learning

- Signs posted for proper hand hygiene, accessibility to restrooms to wash hands or availability of hand sanitizer (as age appropriate)
- Cleaning/disinfection plan includes a schedule for at least daily cleaning high-touch surfaces throughout the day and additional cleaning as needed, person(s) responsible for cleaning and availability of cleaning/disinfection supplies
- School COVID-19 program coordinator is designated
- Limited nonessential visitors/volunteers/external groups
- Discontinuing large gatherings/activities that do not allow for physical distancing
- Communication Plan when COVID-19 case identified at school

Requirements for In-Person Learning

- Masking Policy in place
- Physical distancing (ideally, at least 6 feet)
- Policies encourage students/families/staff to stay home if sick
- Plan for organizing students/staff into small groups (cohorts) that remain together, with limited mixing between groups (all day for young students and as much as possible for older students).
- Plan for monitoring and excluding if someone gets sick at school
- All Student Support Personnel equipped with PPE including a face shield and mask
- Plan to incorporate and continually reinforce routines of hygiene education and safe practices

All Staff & Faculty Will...

- Limit social gatherings & traveling as much as possible!
- Report anticipated or not, incidents of exposure
- Complete daily wellness screening and remain home when ill
- Re-education and monitor keiki on safety and health protocols
- Support educational goals of keiki in any and all learning model formats

All 'Ohana Will...

- Limit social gatherings & traveling as much as possible!
- Keep keiki home when sick
- Upon a call from the school to pick up a sick keiki, pick up keiki within the hour
- Support appropriate behavior and attire while online
- Inform Po'ō Tanaka or Ke'ala IMMEDIATELY
Of exposure/contact near someone with a Positive COVID19 test
- Keep in regular contact with Kumu to support educational needs in any learning model format
