Re: SY 2020-2021 Quarter 2 Plan

Aloha kākou,

Mahalo nui for your cooperation in the quick decision for distance learning through quarter 1 of this school year. We appreciate all your support and effort to keep your keiki engaged in learning. You should all be proud of what we have accomplished this quarter!

Moving into Quarter 2, we will be moving forward with a continuation of distance learning, with the modification to increase the number of students who have access to in-person instruction. Identified supports for students may include, for example, students who require specialized learning services, students who need additional academic support, students in key transition grades, new, identified hawaiian language learners and students who lack internet access, or other determining factors.

We will continue to monitor COVID case activity in our community against the newly released Department Of Health metrics triggering learning models for schools. The DOH metrics outline five levels of community transmission of COVID-19 that would trigger corresponding learning model parameters for schools to consider and to assist with decision making. Kawaiikini will reference the metrics in our gradual plans to bring students back to campus.

Next Steps:

1. More in person learning for elementary students in Papa M-6
2. More in personal learning for identified students in Papa 7-12

3. Mask wearing and 6' physical distancing is required for all in person learning
4. Full distance learning is still an option (this may change in the future)

Schedules

The bell schedules will remain the same for now as we work towards a plan for full blended learning, then face to face learning dependent upon specified parameters. Hui Lama (distance learning hui for Papa 3-6) will remain the same through semester 1.

On campus schedules for in-person learning to continue for Monday, Tuesday, Thursday and Friday from 7:45-1:00pm. Safety precautions and protocols will be enforced as this is a major concern for all school community members.

Health & Safety

For in-person learning we will continue and refine protocols:

- physical distancing (i.e., maintaining at least 6 ft distance or 2 arm's length from others)
- washing hands and/or use of hand sanitizers
- Wearing masks upon drop off at campus
- Increased cleaning and sanitizing schedules

Lunch & Bus

Lunch service will be provided beginning October 13th, on Monday, Tuesday, Thursday & Friday by Epic Eats. Menu choices and lunch payments can be processed through EZ School Pay (ezschoolpay.com). Login information is the same for returning 'ohana, while new 'ohana will need to set up an account. Fees are: Nominal \$.10, Reduced \$.50, Full \$3.00 and Limahana \$5.50.

Bus Service will be provided beginning October 13th, to north east and south west routes on Monday, Tuesday, Thursday and Friday. Riders will be visually screened upon entrance and must be wearing a mask. Seating will be 2 per seat, with the exception of siblings or keiki in the same household, who may sit together.
